- At about 10:30 pm, my wife - Danielle Lowell, informed me that someone was in my son's room and that she only got a glance. I asked Josh and he said someone was at the door - but ran away. We checked all the doors to ensure they were locked. A couple of minutes went by and I noticed Josh's room was dark (he usually goes to bed late). I opened his door and when I hit the 2nd step his light came on. I saw Adam Flanders holding my son with knife to his throat. I told him I had already called the police and they were on their way. He told me to tell them it was a mistake or he would kill Josh. I refused and told Adam to drop the knife or I would remove it from him physically. He repeatedly screamed for me to "get the fuck out or I swear to God I will kill him!" I said he was bluffing and refused to go anywhere and would not leave under ANY circumstances. He repeated his request for me to leave again and again. At this point he stabbed Josh and I jumped Adam. I went to grab the hand that had the knife but he swung it at my head and said "I am going to fucking kill you!", I dodged the swing of the knife with my head and the knife stuck my left shoulder. he lashed and stabbed Josh again in the back. At this point I had wrestled Adam to the bed and held the hand he had the knife in with both of my hands. I also lodged my knee into his neck to restrain him. He turned blue but refused to give up the knife. I screamed for my wife for assistance, but she was attending to Josh. A minute or so later an officer entered the room and removed the knife and held Adam down and handcuffed him. At this point I noticed I was bleeding very badly and was told to go to the ambulance. The knife wound was 2-3 inches deep, required stitches and may require surgery. Adam has been harassing my family and Josh for over six months. I have over 50 threatening e-mails. He has vowed to "kill Josh, Danielle, yw, Kaylie, Brenden and then myself."
