3:50:00 "I am on probation and I had to go to juvi for 3 days."

3:50:19 "We got caught and then I went to juvi for two weeks."

3:51:13 "I must have led him on or whatever because he thought we were still together."

3:52:55 "And this is in January and starts emailing me again." (compare to the fact that I filed a police report about Josh harassing/blackmailing me in December)

3:53:55 "I tell him that I don't want anything to do with him period...so I go to the hotel and be with him and what not...that was a few weeks ago."

3:55:05 "And then he wrote me all these emails saying how he was going to kill himself, or how he attempted to or something like that."

3:55:45 "All this yelling...[he said] what do you want, what do you want?"

3:55:57 "He calls back later and he's like, 'I wanna meet up tonight,' and I'm like, I have school and I can't leave anywhere and what not, and he's like, 'Well then let me come to your house.'

**3:56:12 "And I had the intention, I wanted him to get caught so that I wouldn't - so that he would obviously be seen and then it wouldn't have any of these false things and he could actually go to jail. So it was kind of a setup on my part. And I was planning on having him, like I would go downstairs or something like that and then I would tell my dad that he came upstairs or what not. And I had no recollection that he was going to bring a knife or whatever, but he was entertaining the thought a day or two earlier."**

4:03:22 ("So he had the knife and you were holding onto the hand that was holding the knife?") "I was holding, yeah, with both my hands."

4:04:36 "He puts the knife near me or near my throat, and I can't really remember 'cause it's all just a big collage, but somehow I saw the knife and then I realized that he was there and I did not know it was there and I didn't even know he came with it."

4:08:22 ("Now you're indicating that Adam had been making a long series of threats toward you, toward you and your family. Why would you even entertain having him come over?") "I didn't - the threats were - The only threats that were actually serious were ones that he was going to kill me and that wasn't near the situation...it happened a lot previous...He could have killed me at anytime, so I didn't think he was any threat and I just wanted him gone."

**4:09:18 "So I'm like well, I'm gonna let him think that he's gonna come to the house, and then when he comes to the house, I'm going to - he's gonna get - obviously he's gonna - people are - I'm gonna have my dad find him and what not and I didn't think he'd have any weapons on him so he'd be powerless."**

4:09:39 ("Something I'm not understanding, your whole intention was to have him get caught coming to your house, however you let him in the house, you lied to Danielle about who went up into your room - it's not making sense.")

4:10:26 ("It's not really feasible he'd be jumping from one of your windows.") "I just, I didn't really know what to do and I was in panic, and I didn't want them to think any less of me or what not." ("Josh, one thing that I need at this point, and especially from you, is I need you to be 100% honest with me. If you still have feelings for

Adam and things were, you know, things have been OK between the two of you and you wanted him to come over and you know, have him sneak over, spend some time with him, you know, maybe part of the night, and then sneak him back out again, that's fine, I'm not worried about anything that might violate his conditions, might violate your probation, I'm not worried about any of that, OK?...But you need to be 100% honest with me"). "Alright, I am." ("OK, what happened?").

4:12:03 ("I'm gonna see what conversations have been had, and I don't want to have to have you come back down and then all of a sudden I'm finding out things weren't quite the way you told me from reading the emails 'cause it gives both sides of the story, it gives a full conversation, so you need to be straight up with me. Tell me what was going on.")

4:12:45 "The last email that he ever sent to me was, um, before tonight, was, like, it said goodbye or something like that, so, and it was like putting the intention that he overdosed and that he was still alive, so I didn't know if he was alive or not."

4:14:23 "Today, or yesterday, I was wondering what was going on with Adam so I was talking to my friends and I was like, well, have you heard anything from Adam because I think he might have killed himself. And then I was checking up his MySpace and I saw that he wasn't logged on in a while...Somehow I said something like, I know you didn't kill yourself. I know it wasn't through a phone call." [In fact, that's exactly what he texted to me from his cell phone, of which I have a record].

4:17:49 "Somehow I messaged him and I'm like, you're being stupid or something like that and if you really want to talk about this then you can just call me because he didn't have my screen-name unblocked, so I couldn't, there was no other way to contact him but through email." [Why did I block him?!]

4:18:18 "I messaged him back and I'm like, you're being stupid...why don't you stop being stupid and call me...and um, eventually he calls me and he's like, Well what do you want?"

4:18:51 "'Cause he still thinks I want to be with him."

**4:19:58 ("So, are you still in love with him?") "No, I haven't been for a while. And I can honestly tell you that right now, and when he was saying that he was going to kill himself, I was talking to my friends about it and I'm like, I don't know how this makes me sound, but I'm not sure how I feel about it, I don't think I would react in a way that I would sob and everything or weep uncontrollably." ("OK, and this brings us back full circle again as to why you would even consider inviting him to come over. I'm not buying the bit where you were gonna set him up, OK, because that just makes absolutely no sense the way you're explaining it, OK?") "Well it was in my mind that it could happen, and that if something did happen, I could set him up."**

4:21:53 ("Obviously you're trying to keep yourself from getting in trouble, whether it be with your folks, whether it be with your PO, whoever, OK?...")

4:32:53 "By the time my dad started walking up the stairs I started walking towards my dad. And then my dad said something, I can't remember what he said, and then Adam came up behind, me, and then, I just knew that he was like pinning me down and I was like, well I can probably get out of this and then I saw the knife, but I'm like ok this isn't, so I tried fighting it off, and he's like, 'Well you gotta let go'...and he's like 'Josh let go, let go of the knife.'"

4:33:41 "And then my dad came over and he started, whatever with Adam, and then, before, like right when my dad started coming over Adam started swinging and I think that's when he got both of these places, and then I just ran downstairs."

4:33:59 ("Did you hear anything that Adam was saying? Was he making any certain statements, um, with you, with having the knife, holding you down, um--") "The only thing that he ever said was, um, like, 'let go,' or something like that, he's like, or, 'stop it Josh,' or along the lines of 'let go of the knife,' and then he told my dad 'go downstairs now, go downstairs now, go downstairs now,' that's all he really said. And then my dad said something, and then, that's all that, that's all the dialogue that I can remember." ("So he never threatened to kill you?") "I don't think he, I don't think he said it." ("How about your dad?") "I don't think he said that either. I don't think he ever made, like, I'm going to kill you, but he, it was under the impression obviously he had the knife. It knew it could happen, so, and I didn't know what to do, I didn't know if he was fooling around or I didn't know if it was actually for real, so I was actually in panic."
